



LOVE MY PET Photo Contest

CONTEST PERIOD

Bank of China (Malaysia) Berhad [Registration No. 200001008645(511251- V)] ("BOCM") and MSIG Insurance (Malaysia) Bhd [Registration No. 197901002705 (46983-W)] ("MSIG") jointly organise the LOVE MY PET Photo Contest ("Contest") commencing from 1 Jun 2024 and ending on 9 Aug 2024 both dates inclusive ("Contest Period"), unless otherwise notified.

TERMS AND CONDITIONS

The following sets out the terms and conditions applicable to the Contest ("T&Cs"):

ELIGIBILITY

- 1. The Contest is open to all Malaysian and non-Malaysian individuals (including BOCM customers and staff) from age 18 and above residing in Malaysia ("Participants").
- 2. Participants are not required to apply or purchase any BOCM's and/or MSIG's products to participate in this Contest.
- 3. Participants who have committed or are suspected of committing any fraudulent or wrongful acts in relation to any products and/or any of the facilities granted by BOCM or have been declared bankrupt (pursuant to a petition by either BOCM, other banks or by any third party) or are subject to any bankruptcy proceedings at any time prior to or during the Contest Period shall NOT be eligible to participate in the Contest.

(hereinafter collectively referred to as the "Eligible Participants")

Eligible Participants are required to attend to the following:

A) Photo Submission:

- 1. FOLLOW BOCM's Facebook page at https://www.facebook.com/BOCMalaysia
- 2. **LIKE** the post of LOVE MY PET Photo contest on BOCM's Facebook.
- B. **UPLOAD** the pet's photo and write a caption based on the theme of 'Love & Companion' / '爱与 陪伴' (can be written in English or Chinese) in the **comment** box of LOVE MY PET Photo contest FB post. [Note: Any inappropriate photo/content posted will be deleted by BOCM/MSIG.]





- 4. Thereafter, SHARE LOVE MY PET Photo contest FB post on own Facebook page to gain votes in order to be shortlisted as the Shortlisted Finalists (as defined in Clause 2 of Part C below) and continue to compete to be the top 3 winners.
- 5. **Submission Deadline:** The photo submission is opened from 1 Jun 2024. All submission must be received under the post of LOVE MY PET Photo contest on BOCM's Facebook by **11:59am (MYT) on 30 Jun 2024**.
- 6. BOCM/MSIG are not responsible for incomplete or misdirected submission, technical or network malfunctions or failures, or causes beyond their control.

The Eligible Participants are solely responsible for their submissions. The Eligible Participants may not submit materials that introduce any software viruses, worms or other programs designed to damage software, hardware or telecommunications equipment.

B) Photo Rules:

- 1. Photos must be taken with a pet (dog or cat) with or without the pet owner.
- 2. Photo must have a caption which is based on the theme of 'Love / Companion'爱. 陪伴 written in English or Chinese.
- 3. Photo should be taken at the highest resolution possible, and must be submitted in JPG format and not larger than 10 MB.
- 4. Cropped photos are eligible. Minor adjustments, including the removal of sensor dust or scratches on scans of negatives, dodging and burning, sharpening, contrast, toning, slight colour adjustments and conversion to grayscale are acceptable.
- 5. The addition and subtraction of objects are not permitted. However, addition of the caption in either English or Chinese on the photo is permitted.
- Photo must be created / taken by the Eligible Participants and certifies that he/she is the sole creator and copyright owner of the submitted photo. Stock or Artificial Intelligence ("AI") images are not permitted.
- 7. The Eligible Participants shall not submit materials that are off-topic, partisan-political, contain advertising, nudity, personal attacks or expletives, or is otherwise abusive, threatening, unlawful, harassing, discriminatory, libellous, obscene, false, sexually explicit, or that infringes on the rights of any third party.

C) Judging:

- 1. The photo will be judged based on the creativity, quality, originality, responsiveness to the theme of 'Love / Companion' 爱. 陪伴 and overall impact.
- SEMI-FINAL: BOCM will shortlist 20 finalists ("Shortlisted Finalists") based on 60% score from the votes (same mechanism described in Section E), and 40% from the judges appointed by BOCM/MSIG. The 3 Winners (as defined in Part F below) of the Contest will be selected from the 20 Shortlisted Finalists.
- 3. All the Shortlisted Finalists will be notified of their status and the name list of the Shortlisted Finalists will be published on BOCM' Facebook https://www.facebook.com/BOCMalaysia, BOCM's website (www.bankofchina.com.my) or MSIG's Website. The Shortlisted Finalists can reshare the post to earn more votes.
- 4. **FINAL:** The 3 (three) Winners are selected fully based on the highest score from the votes gathered from BOCM's Facebook (refer to clause E. Vote below for details).

D) Shortlisted Photo(s):

- 1. The **shortlisted photos will be posted on 5 July 2024** via BOCM's Facebook page.
- 2. Shortlisted Finalists will be rewarded with a personalized pet pendant with the name of the pet ("Gift").







For the avoidance of doubt, BOCM will inform the Shortlisted Finalists via e-mail to provide their contact number and correspondence address to BOCM within 5 business days from the date of notification from BOCM, for the arrangement of the Gift delivery, failing which BOCM may disqualify the Shortlisted Finalist from receiving the Gift.

E) Vote:

- <u>SEMI-FINAL:</u> The Eligible Participants are allowed to re-share the photo post via BOCM's FB to boost up the photo like and share from 1 June 2024 until 30 June 2024 at 11:59am (GMT+8) (or such other date as may be determined by BOCM) until the voting ends. Voting is calculated based on the number of likes, shares and comment. [60% score from the votes; and 40% from the judges appointed by BOCM/ MSIG.]
- 2. <u>FINAL:</u> The 20 Shortlisted Finalists are allowed to re-share the shortlisted photo post via BOCM's FB to boost up the photo like and share from 5 July 2024 until 5 Aug 2024 at 11:59am (GMT+8) (or such other date as may be determined by BOCM) until the voting ends. Voting is calculated based on the number of likes, shares and comment. [100% score from the votes]
- 3. Score from voting in Semi-Final will not be carry-forward and counted in the Final round.
- 4. The shortlisted photos with the highest score will win the Prizes as provided in Clause 2 of Part F below based on mechanism below ("Winners"):
 - √ 1 Like = 1 point
 - √ 1 Comment = 2 points
 - √ 1 Share = 5 points

F) Winners and Prizes:

- 1. BOCM will announce the Winners on **9 Aug 2024** (or such other date as may be determined by BOCM) via BOCM's Facebook page.
- The top 3 (three) photos with the highest score will win the Prizes as listed below:
 - 1st Prize: MSIG Pet Insurance (Plan 3 Dog/Cat) with pet's medical benefit RM5,000 & more¹; or RM600 Cash Rewards.
 - 2nd Prize: MSIG Pet Insurance (Plan 2 Dog/Cat) with pet's medical benefit RM3,500 & more¹; or RM500 Cash Rewards.

purpose of MSIG Pet Insurance application. BOCM may disqualify the Winners from winning the Prizes in the event the Winners fail to furnish all required information to BOCM within 5 (five) business days from the date of notification from BOCM.

Alternatively, the cash reward can be transferred to the Winners' TouchnGo e-Wallet and the Winners are required to provide his/her mobile number to BOCM for the purpose of transferring the cash reward to his/her TouchnGo e-Wallet.

FAIR USE OF PHOTO

- 1. By entering into this the Contest, the Eligible Participants grant BOCM and MSIG (and those authorized by BOCM and MSIG) a royalty-free, world-wide, perpetual, non-exclusive license to publicly display, distribute, reproduce and create derivative works of the photo(s) submitted by the Eligible Participants, in whole or in part, in any media now, existing or later developed, for any purpose, including, but not limited to, advertising and promotion of the products/services and its website, exhibition, and commercial products (this includes any sales of products utilizing the photo), including publications of BOCM and/or MSIG.
