We are the Institutional Unit Trusts Agent (IUTA) and distribute the unit trust funds from various Unit Trusts Management Companies (UTMCs). As the online provider, we consolidate and place the Customers' Orders with respective UTMC(s) under Pseudo Nominee arrangement.
- 3. You may also obtain a copy of the paper-based prospectus(es) and application forms from our branches and respective UTMC(s).
- 4. None of the unit trust funds mentioned herein have been approved for sale or purchase by any authority outside Malaysia. Therefore, these funds are intended only to be made available in Malaysia or to any person in Malaysia. Any person, resident or non-resident of Malaysia, who buys into these funds will be subjected to Malaysia Laws.
