# TERMS AND CONDITIONS Organiser & Qualifications

- 1. This "BELI & MENANG HADIAH MENARIK BERNILAI LEBIH RM338,000" Contest ["Contest"] is jointly organised by TMG Mart Sdn Bhd (Registration No: 201301026916 (166702-T)) and Payments Network Malaysia Sdn Bhd (Company No: 2000801035403 (836743-D)) (PayNet) [collectively referred to as "The Organiser"].
- 2. This Contest is open to all DuitNow eWallet account users and MyDebit Automated Teller Machine ["ATM"] cardholders issued by participating financial institutions authorizing MyDebit services in Malaysia. The DuitNow eWallet account users and MyDebit ATM card holders must be 18 years old and above are a Malaysian citizen or a permanent resident in Malaysia and has a valid identification document during the Contest Period ["Participant"].
